

TRAVEL REQUIREMENTS SINGAPORE - BATAM / BINTAN

SINGAPORE TO BATAM

- 1** Vaccination certificate (minimum 2 doses)[1], at least 14 days before date of departure. Vaccinated exemption for Travelers under 18 y.o traveling with fully vaccinated adults[2].
- 2** Download and register on Peduli Lindungi apps. Utilize Peduli Lindungi apps for activities in Batam.
- 3** No On-arrival RT-PCR test & required. Except for the following cases:
 1. Travelers arriving with COVID-19 symptoms and/or body temperature above 37.5 degree Celsius (regardless of vaccination status)
 2. Non-fully vaccinated travelers.
 3. Travelers traveling under recovered traveler scheme [3].Travelers have to wait for a negative RT-PCR result at hotel room (picked up from terminal by hotel) or place of residence (show KTP Batam/Surat Domisili/SKTT) before resuming activities.
- 4** Required to show valid Entry Visa for travelers whose nationality is not eligible for free visa or visa on arrival (VOA).

BATAM TO SINGAPORE

- 5** Vaccination certificate (minimum 2 doses). Children under 12 y.o are not required to be fully vaccinated.
- 6** Submit SG arrival card. <https://eservices.ica.gov.sg/sgarrivalcard/>
- 7** Comply with health protocol.

FREE VISA & VOA REQUIREMENTS TO BATAM

- 8** Free visa or VOA travelers are required to show a return ticket or one-way ticket to continue traveling to another country[4].

Travelers whose nationality are from countries listed below may enter Batam with 30 days free leisure visa; not extendable[4].
